### **Objectives & Investment Policy**

The aim is for your investment to reflect the performance of the Solactive Swiss Large Cap Index (NTR) (Index) which is designed to reflect the performance of shares of the 20 largest companies domiciled and listed in Switzerland. The companies represented in the Index are selected on the basis of the combined value of their shares as compared to other companies on the stock exchange. The largest company can make up no more than 32.5% of the Index and all other companies cannot exceed 17.5% of the Index. The composition of the Index is reviewed quarterly.

The Index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax.


To achieve the aim, the Fund will attempt to replicate the Index by buying all (or, on an exceptional basis, a substantial number of) the shares in the Index in the same proportion as the Index as determined by DWS entities.

The Fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. The Fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the Fund.

Dividends may be paid on your shares up to four times per annum

You may redeem your shares on demand on a daily basis.

#### Risk and Reward Profile

The Fund will attempt to replicate the performance of the Index less costs, but your investment is not expected to match the performance of the Index precisely. Exceptional circumstances

may arise, such as, but not limited to, disruptive market conditions, additional costs/taxes or extremely volatile markets, which may cause the Fund's performance to be substantially different from the performance of the Index.

DWS entities and related companies may act in several roles in relation to the Fund such as distributor and management company which may involve conflicts of interest.

The Fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up.

The value of an investment in shares will depend on a number of factors including, but not limited to, market and economic conditions, sector, geographical region and political events.

The Fund may use derivatives to try to manage its investments more efficiently. This may not always be successful and may result in greater fluctuations in the value of the Fund. ### Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

Secondary market investors (those who buy or sell shares on a stock exchange) may be charged certain fees by their stock broker. These charges, if any, can be obtained from such stock broker. Authorised participants dealing directly with the Fund will pay the transaction costs related to their subscriptions and redemptions.

The ongoing charges figure is based on expenses for the year ending October 2018. It may vary from year to year. It excludes portfolio transaction costs and performance fees, if any.

To the extent the Fund undertakes securities lending to generate revenue, the Fund will ultimately be allocated 70% of the associated revenue, the securities lending agent, which will be a DWS entity or other Deutsche Bank entity, will be allocated 15% and the remaining 15% will be allocated to the DWS entity which monitors such activities, as set out in the prospectus. To facilitate this the Fund may receive associated revenues and allocate revenue to the securities lending agent and DWS entity which monitors such activities, in the proportions set out in the prospectus. As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges.
